ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP
OF ANDOVER AMENDING CHAPTER 103 OF THE REVISED GENERAL CODE OF
THE TOWNSHIP OF ANDOVER, COUNTY OF SUSSEX, STATE OF NEW JERSEY,
ENTITLED "PARKS AND RECREATIONAL AREAS"

WHEREAS, the Township has established ordinances concerning the use of public parks and recreational areas which can be found at Chapter 103 Sections 103-1 to 103-7 of the Revised General Code of the Township of Andover;

WHEREAS, the Township has devoted considerable resources to the improvement and maintenance of athletic fields in Hillside Park and Goodale Park and desires to limit the use of the athletic fields during the winter and early spring in order to maximize the condition of the athletic fields during the periods of peak activity in the late spring, summer and fall months;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Andover, County of Sussex and State of New Jersey, that the Revised General Ordinances of the Township of Andover (the Code), Chapter 103, entitled A Parks and Recreation Areas, Section 103-3 entitled Rules of Conduct is hereby amended under 103-3(K) as follows:

Section 1. (K) Utilize designated athletic fields in Hillside Park and Goodale Park between December 1st and April 1st. This period of prohibition of use of the athletic fields may be extended by the **Supervisor of Public Works** as weather conditions dictate.

Section 2. Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 3. All Ordinances and parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. This Ordinance shall take effect upon final passage, adoption and publication in the manner prescribed by law.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Andover, County of Sussex and State of New Jersey, that the Revised General Ordinances of the Township of Andover (the Code), Chapter 103, entitled A Parks and Recreation Areas, be and is hereby amended to add Section 103-3 (K) to the existing Section 103-3, entitled Rules of Conduct as follows:

Section 1. (K) Utilize designated athletic fields in Hillside Park and Goodale Park between December 1st and April 1st. This period of prohibition of use of the athletic fields may be extended by the Supervisor of Public Works as weather conditions dictate.

Section 2. Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 3. All Ordinances and parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. This Ordinance shall take effect upon final passage, adoption and publication in the manner prescribed by law.

SO ORDAINED, as aforesaid.
