#2006-24 TO ADD CHAPTER 68 BUS TRANSPORTATION SERVICES NOTIFICATION

"AN ORDINANCE OF THE TOWNSHIP OF ANDOVER, COUNTY OF SUSSEX AND STATE OF NEW JERSEY TO ADD CHAPTER 68, BUS TRANSPORTATION SERVICES NOTIFICATION, TO THE REVISED GENERAL ORDINANCES"

Before asking for a motion to open the public hearing, Mayor Walsh asked the Township Committee for a straw poll. He stated that this ordinance was drafted in cooperation with the Board of Education. Mr. Webster explained that the Board of Education had expressed many problems regarding the school bus transportation situation. Every year the school employees are flooded with phone calls and complaints as to where their children's bus stops are located.

ORDINANCES: PUBLIC HEARING (CONTINUED)

#2006-24 TO ADD CHAPTER 68 BUS TRANSPORTATION SERVICES NOTIFICATION

Mr. Webster stated that once this ordinance was introduced he heard back from the Board of Education stating there were more issues and they were not ready to move forward. Mr. Webster advised them that the only reason this ordinance was considered was because of their complaints and request for assistance from the township.

There were comments from the public with regard to the penalty clause of the ordinance finding it to be too strict. Mayor Walsh explained that the penalties stated are "up to" a certain amount. The penalties mentioned where not the minimums, but the maximums.

A straw poll to approve this ordinance was conducted and the results are as follows:

Mayor Walsh - no

Mr. Webster moved to open the public hearing, seconded by Mr. Gilsenan and carried unanimously.

Ken Marvec, President of the Sussex County Board of Realtors asked that if the Township Committee were to reconsider this Ordinance at any time that perhaps they could reach out to the Association so conditions could be discussed prior to any further action.

Resident Carla Kostelnik was present and she stated that this issue is a School Board problem and the responsibility should lie with them.

Attorney Semrau explained that since June 2006 there were numerous discussions and then given direction to proceed with a draft. He referenced the penalty clause and stated that in order to give a Court latitude that is the language used for any violation.

Ms. Phoebus asked if there is anyone present from the Board of Education. Mr. Pierson stated he was not here for this hearing and was not aware of this ordinance. He added that he is also on the Transportation Committee. He stated that every September it is a nightmare in the office with complaints from parents regarding school bus stops. The Township Committee asked that Mr. Pierson speak with Business Administrator VanAuken and School Superintendent Jerry Clymer regarding this situation. Mr. Webster stated that he has been in conversation with both of them all along and is very surprised by this.

Doreen Keller of Goodale Road expressed the need for the township to balance the good use of tax dollars versus what is not necessary and this ordinance is not necessary. She added that she has witnessed through the past several years many times that the township has spent funds unnecessarily. Mayor Walsh asked Ms. Keller if she has noticed a change since June in wasteful spending of tax dollars. She agreed and Mayor Walsh explained that this Committee can not be held responsible for the actions of past committees.

ORDINANCES: PUBLIC HEARING (CONTINUED)

#2006-24 TO ADD CHAPTER 68 BUS TRANSPORTATION SERVICES NOTIFICATION

The Township Committee stated this Ordinance was discussed during the Joint Meeting of the School Board and Township Committee and only six people were present.

Ms. Phoebus asked Mr. Pierson how many people are present during a Board of Education meeting. He replied that the same five people are at every meeting.

There were comments asking that the School Board consider easier methods to address this problem rather than have an Ordinance requiring a certification which can change several times a year depending when homes are sold. There were comments regarding the placement of bus stop information on the website. Ms. Phoebus stated that due to a public safety concern this information can not be made available to the general public.

Mr. Gilsenan moved to close the public hearing, seconded by Mr. Webster and carried unanimously.

Mayor Walsh asked for a motion to adopt Ordinance #2006-24 "Bus Transportation Services Notification". Mr. Grotyohann moved to adopt this Ordinance as presented, seconded by Ms. Phoebus. Roll call vote:

MEETING RESUMED AT 8:45 P.M.

OPEN TO THE PUBLIC A resident asked about the issue of Shared Services discussed under the Executive Session. Mayor Walsh explained that we are in discussions with Andover Borough regarding police and court services. There is a possibility of discussing plumbing and building inspection services. He added that we currently have a shared service with Andover Borough for Road Department services. Mayor Walsh stated there is a push by the State encouraging shared services for a way to say tax dollars. He explained that Administrator Padula has been in contact with the State with regard to the availability of grant monies for shared services which would subsidize the costs.

Page - 7 - ANDOVER TOWNSHIP COMMITTEE

OPEN TO THE PUBLIC (CONTINUED) The resident stated that Township residents pay \$120.00 per person for police services and the Borough would pay \$40.00. Mayor Walsh explained that right now and as it has always been, our police department responds to Andover Borough 30 percent of the time and we receive nothing from the Borough for this service. The State Police contacts Andover Township for assistance and we must respond when they can't. Chief Coleman stated that the State Police does not have the manpower to respond in a timely manner. She asked if Andover Township Police Department has the manpower. Chief Coleman explained that is something that is currently being reviewed.

Mayor Walsh asked this resident to identify herself, Mrs. L'Hommedieu of Cherokee Road, Rolling Hills.

Steve Dugan, Andover Township Volunteer Fire Department member for 13 years stated that he has witnessed many times in those years that our police department has responded to Andover Borough and there has never been any compensation for this service. He commends the Township Committee in taking the necessary steps to see that Andover Township receives something for their response to Andover Borough for all these years.

Mayor Walsh stated that if we could assist another town and add personnel to our department in the process by way of State funding this is something that should definitely be investigated. By having the funding to add manpower, which will mean better coverage in Andover Township.

Mayor Walsh stated that if there is agreement, this will be tried for one year. Administrator Padula stated that we are currently completing the fourth year of a five year contract regarding Road Department services. Mayor Walsh stated that the last administration never applied for any grants for this shared service.

Resident Phil Boyce asked about the Possibility of Violation of the Law matter listed under Executive Session. Mayor Walsh stated this issue can not be discussed at this time.

Dan Freed, Open Space Committee member made a formal request to put the mechanism in place for the Open Space Trust Fund. There was a consensus by the governing body to direct Attorney Semrau to begin this process. Attorney Semrau stated everything will be in place by the first of the year.

Doreen Keller remarked about the parking situation on Goodale Road during soccer tournaments. Mayor Walsh stated promises where made to run van shuttles from Hillside Park to alleviate the parking problem. Various solutions were discussed at this time. He will look into this matter with Administrator Padula and Supervising Laborer Dickinson.

Mr. Pierson was present on behalf of the Highlands Soccer Club. He referenced his email to the Recreation Director regarding their request for turf fields in Andover Township. There was discussion regarding how these fields though expensive in the beginning will eventually pay for itself through the maintenance savings.

Hearing nothing further from the public, Mayor Walsh closed the public portion of the meeting.

OTHER BUSINESS

DISCUSSION REGARDING WEB/NETWORK SERVICES Mr. Webster explained that Bob Smith, a member of the Recreation Committee has volunteered his services to redesign the municipal website. He has assisted the municipal staff in resolving many of their computer issues. Mr. Webster stated he and Mr. Smith had some discussions about the use of computer facilities throughout the township. The police department, the school board and the municipal building all have their own contractor. He and Mr. Smith discussed this and thought perhaps we could save money for the township by bringing all services under one contract and eliminate the possibility of duplication of services.

Ms. Phoebus stated she was present during this meeting and she said the knowledge that both Mr. Webster and Mr. Smith bring to this township we should all be very thankful. We are lucky to have these gentlemen because they understand this process and can save the township some money.

Decision was made to have Mr. Webster and Mr. Smith continue to research this issue. Chief Coleman informed the Township Committee that he had made a recommendation in 2005 to bring the contractor for the on board in the municipal building in order to attempt to do the same thing.

PROPOSED AMENDMENTS TO THE CURRENT FENCE ORDINANCE

Mayor Walsh explained that this Ordinance was revised several months ago because certain fence heights referred to in the Ordinance were only available through special order. He suggested that any further amendments to this ordinance should be handled through the Master Plan amendment process. Additional comments were made at the time of the public hearing, those comments have been incorporated and the draft Ordinance will be forwarded to the Land Use Board for consideration in the Master Plan. All members agreed.

COMMITTEE REPORTS

MR. GROTYOHANN. He reported the next Board of Health meeting is scheduled for Wednesday, December 13th. He and Administrator Padula continue to meet with various health insurance companies in an attempt to save some money. The task is to keep the benefits the same but save money where we can. Progress is being made.

There was a meeting on the proposed Town Center and we are moving forward and negotiations are continuing.

MS. PHOEBUS. She reported on the Senior Luncheon thanking Jackie Huelbig and the entire Recreation Committee. They provided all the food. The New York City bus trip is scheduled for this Saturday with a waiting list if there are cancellations. She reported that on Sunday, December 3rd, the Children's Holiday Party is scheduled for 2:30 at Hillside Park Hall.

The teen dance was a great success and the 7th and 8th graders really enjoyed themselves. She stated the DJ is provided by a private donation made by one of our residents.

She informed everyone that Andover Township Day is scheduled for May 2007 and if anyone wants to assist, to please contact the Recreation Committee.

Ms. Phoebus stated that the newly installed message board is working out very well.

The Fire Department's monthly meeting is scheduled for Monday, December 4th and she will provide a report at the next Township Committee meeting. Regarding the cistern ordinance draft and review, the proposed amendments are being reviewed by Attorney Semrau and an introduction should be scheduled.

MR. GILSENAN. He reported that on December 5th, he and Chief Coleman will be going to the Sussex County Court House to inspect the walk through metal detectors and will report their findings at the next meeting.

He also stated that Administrator Padula had advised that the Homeland Security Defense Grant funds can be applied to this purchase.

He reported that he was unable to attend the last Environmental Commission meeting due to personal reasons. Chairperson de Vries reported that there was not a quorum available for this meeting so there was an informal discussion held regarding detention basins.

Mayor Walsh asked Ms. de Vries to ask Diane Gillespie to visit Goodale Road and give an opinion as to what can be planted there to provide a proper buffer between the park, the road and Mrs. Keller's home. It was reminded that free trees were offered last year to provide a buffer in this area and the former Administrator had refused them.

COMMITTEE REPORTS: (CONTINUED)

MR. WEBSTER. He reported that he will contact School Board Administrator VanAuken and the president of the Sussex County Realtors Association and come up with a solution to the bus transportation issue. A suggestion was to make school information a part of the municipal welcome packet.

REPORT FROM THE TOWNSHIP ADMINISTRATOR He reported the scheduled date for the receipts of bids and supporting documents for the new distribution liquor license is December 11th at 1:00 p.m. The actual bid opening is December 18th.

He stated that \$12,259.56 was received through the sale of surplus municipal equipment held in Sparta late last month.

Assemblyman Guy Gregg called and confirmed that the next phase of Department of Transportation grant funds have been awarded and Andover Township will receive \$150,000.00 for Skytop Road Phase IV.

He recommended that beginning next year we should consider Workshop Sessions in order to discuss certain topics before action is taken at a Regular meeting.

He reported that he contacted a local physician who will provide a program on Stress Management on December 15th. There is no charge for this seminar. All employees will be invited to attend.

Administrator Padula reported that traffic lines were placed on Huntsville Road, Yates Avenue and Skytop Road. The drainage projects for Hillside Avenue and Fenner Drive have been deferred until the Spring 2007.

He stated that due to the efforts of Bob Smith, who volunteers his time almost everyday in the municipal building assisting employees with computer issues and updates our website regularly, he strongly recommends that he be named Citizen of the Year for 2006. All agreed.

Mayor Walsh informed everyone that Attorney Semrau reviewed several avenues in which the municipality could be eligible for additional revenues. With regard to liquor licenses, Andover Township has reached its capacity for its population. But he discovered the fact that Andover Township does not have a Distribution License and we are entitled to one. Bids with a minimum of \$150,000.00 will be accepted shortly. We had three interested people pick up bid packets.

Administrator Padula also stated he is in the process of filing an application for the Mayors' Wellness Grant.

REPORT FROM THE CHIEF OF POLICE He reported year to date Andover Township dispatch has received 7,707 calls for service, Andover Borough 260, Hamburg 4,974 and Green Township 484. Chief Coleman stated he will prepare a year end report for the last meeting of 2006.

He also notified the Township Committee that the recruit Daniel Kern will be graduating from the Police Academy on December 7th. All are welcomed to attend.

REPORT FROM THE MUNICIPAL ATTORNEY He reported that he will be working on the Open Space Trust Fund and the initial tax has been set at \$.01 for the first year.

Regarding the request for a Growth Share Ordinance and Andover Township has no affordable housing funds at all, Planner McGroarty, Attorney Germinario, Mr. Webster and Planning Board Chair Christodlous have met and submitted for the Township Committee's consideration, a draft. Planner McGroarty offered to attend the next meeting in order to explain the Ordinance. Attorney Semrau stated that the draft is consistent with the Third Round rules and a lot of thought went into it in order to address the township's situation. They agreed the Planner should attend and if anything needs to be amended it can be done prior to introduction and final adoption.

Attorney Semrau then referenced the Developer's Fee Ordinance but he stated that can not be addressed at this time because we need COAH approval for the form of the Ordinance.
