Mr. Gilsenan moved to approve the Liaison and Subcommittee appointments as aforementioned, seconded by Ms. Phoebus and carried unanimously.

<u>OPEN TO THE PUBLIC:</u> Environmental Commission Chair de Vries asked if the Liaison List will be available as in the past. Mayor Walsh stated that as soon as the Clerk returns, she will have copies placed on the table for the public.

Resident Diane Gillespie began by apologizing to Mr. Webster because he asked her not to speak at this meeting with regard to his resignation, but she stated she can not remain silent. She stated she has supported all of the Committee's candidates and worked on some of the campaigns. She does not understand why adults, whom the residents supported and elected, can not work together for the good of the township. She reminded everyone that they all sit on the Township Committee because the residents of Andover Township voted for them to bring about change and not to become politicians. She added that she did not expect to witness behavior that we all have abhorred from past committees. She asked that in the future, any committee person has an issue with another committee person, I expect these individuals to talk it out, shake hands and come back and do your job for the township.

**<u>OPEN TO THE PUBLIC: (CONTINUED)</u>** Resident Grace Massaro of Current Drive presented documentation from the Farm Bureau whereby the State is considering a Farmland Assessment Rollback. There are three congressional amendments which will change the rollback procedure anywhere from seven to nine years. She asked if the governing body would send a letter to State in opposition of this legislation. Mayor Walsh asked that she give Attorney Semrau the documents she has for his review. Mayor Walsh then stated following attorney review this issue can then be discussed for consideration of further action.

Resident Stan Christodlous spoke and in reference to Ms. Gillespie's statements made earlier and in all due respect, he stated he knows that Mr. Webster would be very upset when he learns about what said tonight. He added that Mr. Webster called him tonight and told him, he wanted to make it clear that if anyone said anything about his resignation, he wanted everyone to know that it was for personal reasons. He also stated that Mr. Webster wanted no hard feelings between board members and citizens.

Resident Fred Gillespie commented on Mr. Webster's decision to resign from the Township Committee. He stated that he believes that Mr. Webster absence from the Land Use Board and resignation from the Township Committee is the result in part of some accurate information, some partial information, some rumors and some half-truths. He applauded Mr. Webster for his hard work and dedication to Andover Township. He did considerable research and was not afraid to challenge anyone.

In final comment, he stated that the township committee could fight the battle and pay now or not fight and pay later.

Tony Massaro stated to the governing body, that he is not aware what the comments mentioned tonight are about but he wished to congratulate all of the members for being a very fair group of individuals.

Resident Laura Gilsenan stated each member of the governing body ran on a platform of stabilizing taxes and her taxes have increased. She asked if this is still a priority to each of the members. Mayor Walsh started with Mr. Gilsenan.

Mr. Gilsenan stated the key and number priority for him in order to stabilize property taxes is to control residential development which is taxing our school system.

Mr. Grotyohann stated that we need to reduce spending and costs. If we increase our spending to fend off litigation and development at this time, the tax rate is increasing again this year. He asked if that happened would she be here next year saying that there were tax increases. Ms. Gilsenan asked Mr. Grotyohann is it more expensive to pay for litigation now or to pay for the increased demand on our schools created by development. Mr. Grotyohann commented that Ms. Gilsenan made a good point but at this time Andover Township does not have a slew of applications for development we need to be concerned with. He referenced newspaper articles where applications are currently being withdrawn in municipalities, Hovnanian pulled out of Andover Township, one withdrew their application in Franklin.

Ms. Phoebus stated she has been a resident since 1957 and got involved because to be honest, there is no way she can retire in this State. Something needs to be done in the State of New Jersey regarding property taxes. She stated she is in favor of controlling property taxes because if we don't, she can not afford to live or do business in New Jersey. The hardest part is the school taxes and Trenton controls the largest portion and the municipality can do very little. She agreed that if we bring more people into town and flood the school system that will create higher taxes. We do have to do some development that are good ratables and will not affect the school system. We need to manage, control and watch how things are developed. The bottom line needs to be watched closely and controlled.

**OPEN TO THE PUBLIC:** (CONTINUED) Mayor Walsh agreed but added that we can not pin hole it as just development. There has to be proper development, we need to look for ratables in proper places, shared services and streamline government. Mayor Walsh stated that we just found \$80,000.00 in the road department budget because of possible shared services with Sussex County in using their salt shed. We've been in shared services with Andover Borough for five years but because of the past administration, we never received any tax benefit for this service. Mayor Walsh commented that the largest part of the tax bill is the school tax but the majority of the residents come to township committee meetings and no one attends Board of Education meetings where the bulk of the dollar is being spent. He added that increases are due to poor planning in the past, but it is everything not one thing. We need to keep our senior citizens in their homes in our town. If they sell and they will sell to families with four and five children, it will impact our tax base and that is not a result of development. He added that this is about the whole of the township, not one issue. The Township Administrator has been asked to streamline government in order to control tax increases. He stated that everyone will see a definite change this year.

Ms. Gilsenan then asked Mayor Walsh for examples of what he has done in his two years in office. Mayor Walsh stated what he just mentioned is what he and the Township Committee has done. He referenced the Wawa application approval. Benefits will be reaped in the coming years, not immediately. He also mentioned paying for past mistakes.

Stan Christodlous asked Mr. Grotyohann if he meant that because there are no current applications, we do not need to plan for further applications. Mr. Grotyohann replied no. At this time there is no rush at this time. He suggested waiting for the Master Plan revisions. Mr. Christodlous stated that he believes ordinances can be adopted at this time based on the existing Master Plan and to not do that would be criminal. He added that proper ordinances can protect the township.

Mr. Massaro suggested proper planning and taking the burden away from the elderly. He stated that the school budget passes every year. He thought that once a resident reaches a certain age and no longer has children in the school system, a tax benefit could be afforded to that property owner.

Hearing nothing further from the public, Mayor Walsh closed the public portion.
