<u>PUBLIC PORTION</u> James Woodstrom of Limecrest Road stated he has had a shed up for 10 years and in 1997, 1998, 1999, 2000 and several times in 2011 he came down to the town hall and asked if he needs a building permit for a shed. In 2002 he bought a tractor and then decided to build a shed and since November 21, 2001. Since that time the building inspector has come to his house for various inspections and he has also visited his neighbor where he had view of the shed from there. His neighbor has also had three different inspections through the years. Mr. Woodstrom stated he has been voicing his opinion that we do not need a full time building inspector. Last Thursday he received a notice of violation for not getting a permit for a shed. His neighbor received a notice for erecting a shed and swimming pool without permits. For 10 years he was either not doing his job or this is some type of intimidation tactic.

Mr. Woodstrom then stated he has copies of Saturday's Daily Record regarding why the State is laying off their code officials. The reason is there is no construction going on. He said Andover Township also has no construction.

OLD BUSINESS

REVIEW AND CONSIDERATION OF ORDINANCE AMENDMENT REGARDING CHAPTER 30, SECTION 30-10 "FEES" UNIFORM CONSTRUCTION CODE

Following a conversation regarding the need for additional information and taking into consideration that our proposed fees are somewhat in line with other municipalities, the Committee decided to send this draft back to the construction office for further review and explanation of the changes being considered.

NEW BUSINESS

PAY TO PLAY ORDINANCE DRAFT REQUEST Ms. Phoebus stated she spoke to Attorney Semrau after the last meeting regarding her concerns over some groups throughout New Jersey calling themselves PACS. Sometimes these groups get together and they accumulate funds and these funds are given to people running for municipal offices. In return, not being said, they expect certain people hired to do jobs within that municipality.

Attorney Semrau said the State has enacted Pay to Play legislation and it calls for professionals to disclose their political contributions. If there is over \$300 paid to any particular campaign then the position has to go out for request for proposals. That professional can then be appointed even if a larger contribution was made to a campaign. It also gives municipalities the opportunity for more restrictive rules. A number of communities, about 100, have taken it upon themselves to adopt local Pay to Play Ordinances. A draft was provided to the governing body for their review and comment. This Ordinance drafts states that if a contractor were to make a contribution greater than \$300 they would be precluded from being hired by the municipality. This Ordinance would cover every appointment except those that go out for formal competitive bid. The Ordinance, if adopted, would be filed with the State Attorney General's Office.

Attorney Semrau stated he wants to further review this Ordinance draft and coordinate with the Clerk as to terminology regarding any type of proposal within this Ordinance.

Ms. Thompson explained requests for proposals were received and Abcode Security submitted the lower proposal, copies provided to the Township Committee with a draft resolution. Mayor Boyce stated he met with Superintendent Bernie Baggs and Mayor Morgan of Andover Borough at the Community School Night. They are presenting their new budget this evening at the school and they would like to come once again before the Township Committee to discuss their budget. Mr. Baggs suggested an alternative format to the customary presentation. There are four scheduled hearings on this issue and the Committee members could go to one of these meetings. Another option is to do a workshop with school board if we need to spend more time. The Committee agreed to attend the four available scheduled meetings.

Mayor Boyce stated there is a scheduled ice cream social for election night. Attorney Semrau cautioned them to check this out because it may be found to be improper to do so to encourage voting. The school officials should check with the County Superintendent.

Attorney Semrau stated this governing body is in a bit of a situation when the school board comes before them. It appears that they are almost seeking an endorsement. Ultimately, this Committee is the Board of Appeal. He said that this Committee going to their meeting may be the better thing to do.

COMMITTEE REVIEW OF THE 2011 MUNICIPAL BUDGET DRAFT

Mayor Boyce explained that all members received a copy of the latest budget draft along with a memo from CFO Magura. This memo indicates that a significant number of cuts in this proposed budget need to be addressed. Mr. Smith stated this is a first draft and there have been no cuts made. The bad news is that if we were to look at a flat tax increase we would have to cut \$586,000 from this budget. The second element is we are required to cut \$47,000 under the CAP to meet the State requirements. The revenues are being anticipated down a huge amount, \$467,000. He stated he has questioned that number. Another issue is the Capital requirement which is up \$242,000 this year. The auditors are recommending that full amount be paid off in the same year the expense is acquired.

COMMITTEE REVIEW OF THE 2011 MUNICIPAL BUDGET DRAFT (CONTINUED) Mr. Smith then stated that we should not look to reduce the surplus at all this year. The biggest expense in this budget is in Salaries and Benefits. He said it may come to the point where we may have to consider terminating some employees to make our goal. The auditor provided four figures each representing from a zero increase to a three cent increase. He said his goal would be a zero increase. He does not know if we can get there, but that should be our target.

Mr. Walsh remarked on some of the line items saying some issues should be further reviewed. There are figures in the revenue that should not be listed as revenue in 2011. Mr. Smith stated the Auditor will not recommend zero. Ms. Phoebus stated \$5000 was omitted from this budget as aid to the fire department. This amount was returned to the budget by the department last year but they need it this year. Mr. Smith stated the Finance Committee is looking for suggestions and recommendations on this draft. Mayor Boyce added that Mr. Smith has done a good job meeting with all department heads, going over the budget line by line. He said that sometimes department heads pad their budgets a bit to cover unforeseen expenses. Mr. Smith said we looked at some and made small modifications but nothing drastic was done. He wanted to see what the overall picture was going to look like.

Following a detailed discussion of this draft budget it was recommended by the Committee that this draft be further reviewed for additional cuts and adjustments. Mr. Smith said he feels the same as everyone else and believes we are all going in the same direction. He is asking for input from each Committee member. The Finance Committee will meet again. Mr. Walsh suggested each liaison sit with their departments to see where additional cuts can be made.

BE IT FURTHER RESOLVED, that the Township shall pay the County of Sussex the onetime fee of \$1500 for the computer system service implementation and this payment shall be subject to certification of funds by the Chief Financial Officer.
