AN ORDINANCE OF THE TOWNSHIP OF ANDOVER, IN THE COUNTY OF SUSSEX AND STATE OF NEW JERSEY, TO MODIFY CHAPTER 10, SECTION 13, "ONE-WAY STREETS"

BE IT ORDAINED, by the Township Committee of the Township of Andover, in the County of Sussex and State of New Jersey, as follows:

SECTION 1. The Code of the Township of Andover is hereby amended at Chapter 10, Section 13, entitled "One-way Streets," to read in its entirety as follows:

10-13 One-way streets.

The following described streets or parts of streets are hereby designated as one-way streets in the direction indicated.

Name of Street	Direction	Limits
Cedar Drive	Eastbound	Between Pinecliff Road and Prospect Place
Pinecliff Road	Southwest	Entire length
Ridge Road	East and north	Between Cedar Drive and its easterly terminus at Pinecliff Road
<u>Current Drive</u>	<u>Northwest</u>	<u>Between Limecrest Road and Newton Sparta Road</u>

SECTION 2. All ordinances of the Township of Andover which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 4. This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.

10-13 One-way streets.

The following described streets or parts of streets are hereby designated as one-way streets in the direction indicated.

Name of Street	Direction	Limits
Cedar Drive	Eastbound	Between Pinecliff Road and Prospect Place
Pinecliff Road	Southwest	Entire length
Ridge Road	East and north	Between Cedar Drive and its easterly terminus at Pinecliff Road
<u>Current Drive</u>	<u>Northwest</u>	<u>Between Limecrest Road and Newton Sparta Road</u>
