AN ORDINANCE TO AMEND CHAPTER 119 ENTITLED  
"POLICE DEPARTMENT", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF ANDOVER,  
SECTION 119-8  
"CONTRACTED OFF-DUTY EMPLOYMENT"

WHEREAS, the Township Committee of the Township of Andover has established a policy regarding the outside employment of off duty law enforcement officers of the Andover Township Police Department as recited in the Revised General Ordinances of the Township of Andover.

NOW THEREFORE BE IT ORDAINED by the Township Committee of the Township of Andover that the Chapter 119, Police Department, of the Revised General Ordinances of the Township of Andover, be amended as follows:

Section 1. D. Rates of compensation, administrative fee, payment for services.

(1) Rates of compensation for contracting the services of off-duty law enforcement officers shall be \$76.50 per hour effective through December 31, 2019. Effective January 1, 2020, the rate of compensation shall be based on a rate equal to time and one half of top step Sergeant, according to the salary guide within the Collective Bargaining Agreement between the Township of Andover and FOP Lodge #177.

Section 2. All Ordinances, codes or parts thereof inconsistent with any of the provisions of this new Section are hereby repealed to the extent of such inconsistency. If any Section or provision of this Chapter shall be held invalid by any Court of competent jurisdiction, the same shall not affect the other Sections or provisions of this Chapter, except so far as the Section or provision so declared invalid which shall be inseparable from the remainder of any portion thereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon its passage and publication according to law.
