FLAG SALUTE - RULES - OPEN PUBLIC MEETINGS ACT

OPEN TO THE PUBLIC – The Chairman opened the meeting to the public.

With no members of the public speaking up, Chairman Christodlous stated that this meeting is expected to be a short meeting as there are no applications to be considered, however, in consideration of our professionals, the meeting is taking place to go over the vouchers.

Smith stated that he wished to obtain a copy of the planning/zoning budget so that the Board can keep an eye on the budget. The Board Secretary stated that most of the expenses are escrowed monies, along with other expenses, and she would get copies of the budget in order for the Board to have a total overview.

Phoebus wanted to know the Board's opinion of the artistic landscaping on the windows at Cumberland Farms. Boyce stated that although she was not too pleased with the way it looks, she realized that the applicant was told that he could get students to paint the windows. Some of the other members were also not too happy with the way the windows looked but Christodlous mentioned that this was a temporary measure.

Pattison questioned DeVries about an article that she saw in the Township Journal that suggested that the State is now trying to make lawns be called "impervious surface". DeVries answered that no one is making lawns impervious surfaces, however, the article has to do with the Highlands so it does not have to do with this township anyway. Boyce asked a question whether or not other municipalities are coming together and writing to the Council on Affordable Housing regarding the new Third Round Rules. Municipalities to help with this. There was some more discussion amongst the board members regarding the best way to handle the COAH situation.
