# **ORDINANCE NO. 2014-07**

AN ORDINANCE OF THE TOWNSHIP OF ANDOVER, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY TO AMEND THE TOWNSHIP CODE BY AMENDING CHAPTER 10, "VEHICLES AND TRAFFIC," SECTION 10-11, "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS," AND SECTION 10-21, "VIOLATIONS AND PENALTIES," TO ESTABLISH A NO PARKING ZONE AT HILLSIDE PARK BARN

**WHEREAS**, there is within the Township of Andover a structure known as Hillside Park Barn, which area is often utilized for public and recreational purposes; and

**WHEREAS**, there is currently in existing signs at the Barn stating, "No vehicles beyond this point"; and

**WHEREAS**, despite the existence of these signs, vehicles are frequently driven onto and parked in the area between the Hillside Park Barn, the Hillside Pavilion and the Hillside House; and

**WHEREAS**, such access and parking presents a public safety concern to the Township as it has in the past prevented access to Township emergency vehicles; and

**WHEREAS**, the Township desires to keep such area clear for the purposes of public safety and health.

**NOW THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Andover, in the County of Sussex, and State of New Jersey as follows:

**SECTION 1**. Chapter 10, "Vehicles and Traffic," Sections 10-11, "Parking Prohibited During Certain Hours on Certain Streets," and 10-21, "Violations and Penalties" of the Code of the Township of Andover, is hereby amended and supplemented to read as follows:

## § 10-11. Parking prohibited during certain hours on certain streets.

A. No person shall park a vehicle between the hours specified any day (except Sundays and public holidays) upon any of the streets or parts of streets described.

**SECTION 2.** All Ordinances of the Township of Andover, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, sentence, clause of phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 4**. This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.

**SECTION 5**. This Ordinance may be renumbered for codification purposes.
